2.) PBIS K-6 Discipline	ATTENDANCE POLICY
Ms. Pelton began by defining a basic understanding of PBIS, which is moving from a dictatorship discipline to an authoritative discipline that makes use of teachable moments appropriate by age and action.	
Ms. Pelton provided studies (John Hopkins, Columbus City Schools: Student Support Services – Attendance Tool Kit, and NYC Principals' Guide) for review by the Policy Committee members.	
WCSD current policy, at the elementary level, the first interaction is after 10 days. The amount of time before any intervention is too long. Suspensions don't align to the PBIS strategies. Current policy does not align with PBIS when students are suspended and the amount of time taken before preventive measures are taken.	Current Policy
Tracy Pelton provided copies of a powerpoint with specific data in areas across the country which shows a correlation between attendance in Kindergarten and test scores through high school.	IMPACT OF ATTENDANCE
Absenteeism over 10% carries through a student's entire academic year and reduces graduation rates.	
Data supports a policy with early interventions.	
Tracy Pelton provides two sample school districts that have been successful. Both share a common three tier system of interventions.	

Three tier system: 1. Green (majority of students at the bottom) 80-90%	THREE TIER

Mr. Lolkema noted that at the elementary level there is daily attendance but no

3.) RECESS	RECESS
Tracy Pelton indicated concerns with legality of withholding recess. Ms. Kelland	
questioned if the district is using recess as a PE requirement. Mr. Lolkema clarified	
that you can't use recess as part of the PE requirement and there is no legal position on recess. No one in the State is providing enough PE because there are	
position on recess. No one in the state is providing chough PE because there are	

not enough facilities to provide PE. Recess cannot count as PE time and recess is

not a requirement by State Ed.	
Ms. Pelton noted that the Health and Wellness policies that are recommended by the State of New York say that you cannot withhold recess.	
Mr. Lolkema stated that Our Wellness Policy, our attendance policy and the Code of Conduct, nothing supported either having or not having recess. Ms. Pelton indicated that to be a reason for the discussion.	
Ms. Pelton indicated that withholding recess randomly does not support PBIS. Research states that PBIS should be supported by a logical consequence and that unrelated punishment reflects a dictatorship.	
Mr. Lolkema indicated that recess as a form of discipline is an agenda item on the principals meeting tomorrow. Principals feel it is an effective form of discipline to eliminate minutes of recess.	
Ms. Pelton stated that PBIS is supposed to be related to the three "R"s of logical consequence: Respectful, Relevant and Realistic. The foundation for PBIS at the elementary level is to look at your action and to use it as a teachable moment. Taking away recess is a dictatorship, creates fear and it has not been successful.	
Ms. Kelland indicates that it depends on the action. Ms. Kelland believes that losing recess is a logical consequence. She added that PBIS, as she understands it, is a general philosophy and not prescribed for everything. Dictatorship is not the alternative to PBIS. Ms. Kelland shared that you have to consider the experience of the teachers and the situation. There is a difference between a blanket use of taking away recess and targeted uses in specific situations.	
Ms. Pelton said it happens every day and doesn't help the students. Ms. Kelland disagrees and thinks that it is easier to let children go play than to deal with the situation.	
Disagreement over whether recess is a privilege or a right. Discussion on whether loss of recess should be at the discretion of the principal and if principals should have flexibility to use loss of recess as a consequence.	
The meeting was adjourned at 4:45 p.m.	ADJOURNMENT
