- With an AP course there is a lot of work to do outside of the classroom and students do not want that kind of pressure

Mr. Stella and Dr. Bonk – their suggestions -

We want to see more kids taking energizing courses. We need to give AP courses more weight. We would suggest the following:

Honors - 1.05-1.08

AP - 1.10 - 1.13

The state recommendations are 1.05 – honors and 1.1 – AP.

3.) Chaperone policy issues – Anne Brino

CHAPERONE POLICY ISSUES

- Hours are not consistent. If person chaperone's on Friday night, there is a different ending time on each form. School sponsored events extra-curricular activities (skiing, overnight field trip).
- Suggestion to put on field trip form amount of money to be reimbursed, list of chaperone's, # of hours to be reimbursed, hours approved to pay.
- Hourly rate to be reimbursed should be \$21.42 which is \$17.29 for employee, \$1.32 SS and \$2.81 TRS.
