# 2016 - \$26 Million Capital Project

## Phase 1

• Tilcon will be replacing the defective sidewalks at James Evans, Gayhead, Kinry Road and Vassar Road; they will be sending a schedule shortly.

### Phase 2

- A meeting was held with Hudson Valley Audio/Visual and RLJ Electric to review the scope of the auditorium audio/visual systems. They did a walk through at both John Jay and Roy C. Ketcham to see where the final equipment and screens are going to go. After they decide where the equipment can be installed, they will meet with the district to confirm.
- There will be a few contractors working over spring break:
  - o Interior electric work at all of the schools.
  - Measurements are being made for steel to be installed to support the new HVAC rooftop units at both John Jay and Roy C. Ketcham High Schools.
  - There will be an asbestos abatement above the ceiling in the Roy C. Ketcham auditorium and some mudded joints around the HVAC Systems.
  - o The Girl's locker room at Van Wyck will get a new door to meet code.

# 2018 - \$33 Million Capital Project

#### Phase 1

AFI Glass and General Roofing were awarded the Phase 1 Projects. All their references checked out. AFI will be taking field measurements and General Roofing is scheduled to replace a section of the Fishkill Plains gym roof to include asbestos flashing removal over spring break.
