As March begins, we remain focused on our District's mission to empower, challenge and help our students grow. As mandated by New York State, all of our schools have a safety plan. Beyond having a plan, each school practices the components of the plan including drills such as lockdown drills, with local law enforcement present, allowing for ongoing review and improvements. The general safety plans are posted on our website and updated annually. Please understand, in order to maintain the integrity of these safety plans, specific information is not provided to the public, but is reviewed regularly with our staff and practiced with your children.

Although it may be difficult to conceptualize, the WCSD learning communities comprise of the Town of Wappingers, the Village of Wappingers Falls, the Town of Fishkill, the Town of East Fishkill encompassing the hamlets of Hopewell Junction, the Town of LaGrange, the Town of Poughkeepsie and in Putnam County the Town of Kent and the Town of Philipstown. With that said, we recognize the peace of mind it brings to families to see law enforcement officers protecting our students and staff. We have great, productive, collaborative and very positive relationships with our local agencies listed below to provide an additional presence on school grounds.
