## Take 'the plunge' for Special Olympics NY in Fishkill Saturday

Freezin' for a Reason at Camp Mariah at The Fresh Air Fund Sharpe Reservation, 486 Van Wyck Lake Rd., in Fishkill is set for Saturday, Feb. 19. The annual Polar Plunge calls on those willing to jump in freezing water to help raise funds for the athletes of Special Olympics New York.

"It will be similar to last year's plunge. We are still adhering to some COVID

regulations. We feel safety and health are at the utmost importance," said Teresa Gilli, Special Olympics NY. Upon arrival everyone will have their temperature checked.

"We are staggering plunge times by team to keep things safer," noted Gilli. "We will not be using buildings, everything is done outside.

As for what people should know about participating, Gilli replied, "To have fun!

Most are aware of what to expect and we are truly appreciative to all of them for their continued support and dedication to our athletes."

The goal for 2022's event is to raise \$200,000.

"Special Olympics New York would not be able to serve individuals with intellectual disabilities without the participants.

### Central Hudson: Customers to see higher winter energy costs

Central Hudson is advising customers of increases in supply prices for both electricity and natural gas as the region navigates a colder than average winter and as global energy factors come into play, prompting an increase in the demand and price for energy. Supply prices are market-based and not marked-up by Central Hudson.

Contributing to higher commodity prices for electricity and natural gas include:

- Increased domestic demand due to colder weather this year as compared to last year.
- Constrained domestic pipeline capacity which curtails gas supplies.
- Lower electric production by renewable generators in the winter, which shifts power production to generators using natural gas.
- Regionally, an increased reliance on natural gas for power generation following the closure of Indian Point.
- Increased global demand for natural gas, as the United States is now a primary exporter of liquefied natural gas to Europe due to shortages there.
- Increase domestic demand for electricity and natural gas as the economy recovers from closures prompted by the COVID-19 pandemic.

"Locally, this January featured sustained temperatures that were 11 percent colder than average and 16 percent colder than January 2021. This contributed to driving gas usage up more than 13 percent and electric usage up nearly 6 percent over January 2021," said Anthony Campagiorni, Senior Vice President of Customer Services and Gas Operations at Central Hudson. "The increased usage, coupled with international and domestic factors, has caused the market price of natural gas and electricity to rise here in our region and around the world. Natural gas has become a global commodity that not only heats our homes but is also heavily relied upon to produce electricity on demand and whenever needed."

#### Energy bills

Projected Central Hudson bill impacts for natural gas will be an average increase of about 19%; about 46% for electric bills; and about 29% for combination electric and natural gas bills. These bill increases are temporary and may vary for individual customers depending on energy usage and their billing cycle. For example, customers receiving bills now may see the effect of these increases spread out over their current bill and next month's bill.

The increased bills are a result of higher energy prices, which vary and are determined by national and global markets. The February supply charge for natural gas rose 33 percent as compared to January, while electric supply charges have more than doubled. Utility bills reflect the prevailing market prices for natural gas and electric supply and are passed through, without markup, to pay power plant operators and natural gas providers. As such, customers pay the same price for natural gas and electricity supply that Central Hudson does. Higher prices for energy supply may also impact bills for customers who receive electricity and natural gas from

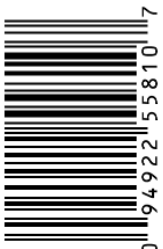

Composers Festival on social media last spring, and I decided to enter the competition."

Messerschmidt described the composition he wrote as "melodic and dancelike with hints of minimalism, but I'm not always the best at describing my music." He noted that a friend of his remarked it has an "epic journey vibes."

According to a description about the Festival, it is a three-day celebration of new and original music from more than 40 composers. With more than 60 diverse compositions performed in four concerts at the De La Warr Pavilion, Bexhill-on-Sea, in the United Kingdom. Performing music written by living composers from all over the world, many of whom will be attending the concerts.

The Festival is scheduled for May and Messerschmidt plans on attending the event.

"I'm sure it will be a really exciting and enriching experience to meet and share ideas with other composers from around the world. I've been very fortunate during the pandemic, but still, after slogging through a couple years of it--dealing with new challenges in teaching, constantly changing childcare arrangements, canceled trips, etc.-it will be wonderful to travel and be surrounded by live music for several days. One of the trips I had to cancel during the last two years was to a conference on music education in prisons in Portugal, so I'm hoping I can use the vouchers from that canceled trip for my flight to the U.K.," Messerschmidt remarked.

Messerschmidt wants to thank those who have helped make this happen for him.

"In particular, I want to thank a couple of Oakwood students (now alumni) who stayed after school a couple of years ago to help me make a multitrack recording of the piece. The recording we made together wound up being the one I submitted with my application to the Festival. So, thank you very much to Elias Fredericks, who's now studying Violin Performance at Peabody Conservatory in Baltimore, and to Stefanie Quintanilla, a violist who's now studying Music Therapy at Temple University in Philadelphia. Thanks also to my family, friends, and colleagues for their support," he said.

third-party suppliers. Click here to view current and historic electric and natural gas supply charges, together with 12-month rolling averages.

Electric and natural gas bills are divided into two main components: Delivery and Supply. Delivery charges are set by state regulators and pay for the energy infrastructure and utility operations, while supply charges are for the electricity and natural gas itself provided by independent generators and suppliers. Central Hudson employs hedging measures to help stabilize natural gas and electric supply costs against fluctuating market prices. These measures include contracting for a portion of energy at fixed prices and purchasing gas at pre-season prices and placing it into storage. For this billing period, these hedging measures are saving customers millions of dollars by reducing the impact of market prices for electricity by approximately 28% and natural gas by 30%. ### Energy Efficiency and Billing Programs

Customers can help manage energy costs

in various ways, such as implementing energy efficiency measures and exploring their billing options.

Low-cost and no-cost efficiency measures homeowners can take to help manage energy costs include:

- Insulating ducts and hot water pipes where they run through uninsulated areas, such as crawl spaces, and repairing leaks in the duct system;
- Adding insulation, particularly in the attic;
- Turning down thermostats (each degree saves up to three percent on energy use);
- Keeping radiators and heating ducts clear of furniture to allow heat to circulate freely; and/or
- Sealing air leaks with weather stripping and caulk, which can save up to 10 percent on the use of heating fuels.

Central Hudson offers energy efficiency incentives for homes and businesses, including rebates of up to \$1,000 on new, high-efficiency natural gas home heating systems, up to \$1,600 on electric heat pump systems, \$250 on indirect natural gas water heaters and up to \$1,000 on high efficiency heat pump water heaters. Budget Billing divides a household's average annual energy bill into 11 even monthly payments, with the 12th month's payment adjusted up or down to reflect actual usage and market prices. This program makes energy bills more predictable and can help in managing household budgets.

Payment assistance options are also available to qualifying customers like the Bill Discount program for income-qualified customers. The federally funded Home Energy Assistant Program (HEAP) grants are now available and the new Regular Arrears Supplement program that provides up to \$10,000 in utility arrears assistance to eligible households who are unable to pay their unpaid electric and/or gas utility arrears.

Central Hudson's Clean Energy Marketplace allows customers to save up to 10 percent on their utility bill while also investing in local clean energy projects. Other programs include Deferred Payment Agreements that help customers catch up by paying a past-due account balance in monthly installments, the Extra Security Plan which offers an extended billing due-date for qualified customers on a fixed income and the Good Neighbor Fund which provides last resort grants for families who have exhausted all other means of assistance. ## COVID-19 update

# New York enters new phase with multi-pronged plan

Gov. Kathy Hochul lifted the mask-or-vax mandate in many public settings last week, enabling businesses and county/local governments to enforce as needed. Hochul based the decision on the steady decline of COVID-19 cases and decreasing hospitalizations.

In Dutchess County, nearly all data points are moving in the right direction (see statistics at the end of this article). A significant amount of COVID-related deaths are still occurring, though: Over the last few weeks, 16-17 individuals have succumbed to the disease.

Hochul outlined the state's plan going forward, the so-called Winter Toolkit that focuses on five core areas: protecting the most vulnerable New Yorkers, increasing vaccinations and boosters, strengthening the state's health care system, empowering local leaders, and supporting individuals facing the long-term effects of COVID-19.

"As we begin a new phase in our response to this pandemic, my top priority is making sure we keep New York safe, open and moving forward," Hochul said. "I want to thank the health care workers, business owners and everyday New Yorkers who acted responsibly during the Omicron surge by masking up and getting vaccinated. But make no mistake: while we're moving in the right direction, this pandemic isn't over, and our new Winter Toolkit shows us the path forward."

As a critical tool to fight the spread of COVID-19, mask requirements will remain in place in certain high-density settings. All health care settings regulated by the Department of Health and other related state agencies will continue to require masks. Masks will also be required in nursing homes, adult care facilities, correctional facilities, detention centers, homeless shelters, and domestic violence shelters, public transit and transportation hubs, as well as trains, planes and airports in accordance with federal regulations.

Hochul also announced plans to assess the mask requirement in schools in early March, to ensure students can continue learning in-person and in the classroom. The assessment will be based on public health data, including key metrics like cases per 100,000 residents, hospital admission rates, vaccination rates, global trends and pediatric hospitalizations.

Plans are under way to distribute two tests for every K-12 student ahead of midwinter break, and continue distribution the following week when students return to school. In the meantime, Hochul has directed the Department of Health to work on preliminary guidance, with input from educators and parents, to keep students and teachers safe.

Increase Access to vaccines, boosters and testing

• New York State's mass vaccination and testing sites will remain open to ensure all eligible New Yorkers can access first, second, and third doses for themselves and their children.

• The State's #VaxForKids pop-up programming continues to expand with 193 sites established to date. This effort brings the vaccine directly to parents, guardians and their children at local schools, community centers and destinations like farmers markets to make getting vaccinated convenient and accessible for families.

• New York State is actively preparing for the Pfizer-BioNTech vaccine to come online for children under 5 years old.

• The State's education efforts to reach New Yorkers with good, science-based information about the vaccine is ongoing including through traditional advertising, digital and multimedia campaigns, and direct messaging efforts through SMS text messaging, robocalling and Excelsior Pass push notifications.

• All 61 state-operated and state-partnered testing sites will remain open to provide New

Yorkers with access to COVID-19 testing.

• Testing also remains widely available at more than 1,800 sites statewide in every region.

### Gas spill worries reader

#### To the Editor:

On Sunday February 6, on the corner of Route 9 and Old Hopewell Road in Wappingers, there was a gasoline spill that caused a widespread area to be filled with noxious, heavy fumes. The initial explanation for the cause of the spill was a failure in the Overfill Protection System as gasoline was being transferred from a tanker truck to the underground storage tanks.

This accident and accidents like it could be in the future of any Town of Wappinger neighborhood.

In March 2019 the Town of Wappinger Town Board removed the Zoning Code that prevents the building of gasoline filling stations in residential areas with no clear explanation or reason for this action. This is in stark contrast to the vast majority of other towns in Dutchess County where zoning protections for residents are in place, and in some cases have recently been strengthened.

The logistics of having to notify and evacuate a residential area or facilities where people gather (schools, nursing homes, health facilities etc.) because of noxious fumes are complicated and difficult. Think of the concerns and details - napping babies in cribs having to be scooped up and taken out of the affected area, individuals with mobility and breathing issues having to quickly leave their homes, school children playing outside having to be gathered up and taken to a safe place because, despite assurances of well monitored and functioning systems and equipment - failures do happen.

Think of the implications to ground water both immediately and over time from such environmental failures.

More than 1,000 residents have petitioned the Town of Wappinger officials to reinstate these Zoning protections. The Town Board has not allowed this request to be introduced as an agenda item in their board meetings.

The Town of Wappinger is also re-considering an application for a Propane Storage Facility near Route 9. While a new decision has not yet been made on this application, a clear declaration by Town Officials that the Town will curb expansion of storage and transfer of large amounts of hazardous fuels would be welcome.

Citizens of Wappingers, please contact your Town Officials to encourage them to support efforts to improve our quality of life in the Town of Wappinger which includes clean air, clean water and reduction in health and safety risks in our neighborhoods.

### Alzheimer's treatment needs full coverage from Centers for Medicare & Medicaid Services

#### To the Editor:

Thanks to our bipartisan champions in Congress, we've made great progress advancing research on Alzheimer's and dementia, providing hope to families in the midst of a terrible diagnosis and disease progression. And now the FDA has approved the first Alzheimer's treatment to address the underlying biology of the disease. It's lifted that hope higher, and there are other treatments close behind in the research pipeline showing even greater promise.

But with the Centers for Medicare & Medicaid Service's (CMS) proposed decision limiting coverage to those in clinical trials, access is severely restricted to only those few who live near research institutions or can afford to pay the \$28,200 annual cost out-of-pocket. CMS has never before limited Medicare coverage like this for any other FDA-approved medication. This is unacceptable.

People with Alzheimer's and their doctors should be able to decide if an FDA-approved treatment is right for them and those eligible should have it covered by Medicare. All those living with Alzheimer's deserve better.

My grandmother and all of us around her lived through the emotional pains of Alzheimer's as do more than 6 million people who are affected. I appeal to CMS to think of the benefit to millions of reconsidering their decision

## Notes from the Town of Wappinger Supervisor

# February Town Board Workshop

Each year, I will hold at least two planning workshop sessions with the Town Board (the "Workshop"). The purpose of these workshops is to discuss various capital projects that would need to be considered by the Board during the calendar year. On Valentine's Day, February 14th, the Town Board held its first Workshop of 2022. During this meeting we discussed a variety of important infrastructure and capital improvement projects. I have summarized key elements of our Workshop discussions below.

• **Financial overview:** Three years ago, as the Town's Chief Financial Officer, I initiated a series of financial initiatives designed, among other things, to increase predictability in our budget process. Most important is long-term capital forecasting and planning, for which project I asked 4th Ward Councilman Al Casella, an IBM financial specialist, to assist. The remainder of the Board members have also been actively involved. During the Workshop, we reviewed various core elements of our capital planning process, including: bond funding, grant funding, federal funding, revenue generation, etc.

• **Highway Garage and the Building and Grounds Maintenance Barn facility:** These building complexes house our two key departments of public works. They are aged facilities that have outlived their useful lives. Last year we raised bond financial to pay for significant renovation of the Highway Garage, on which reconstruction efforts will begin in early 2022.

• **Public Water and Sewer Projects:** Much of our Town's sewer infrastructure is aged and in need of major improvement. Thanks to successful grant applications and federal ARPA funding we will be able to start the refurbishment and expansion in 2022.

(i) Wildwood/Woodhill Green. Several years ago the NY State DEC issued notices of violation against the Wildwood sewer plant, which means it must be decommissioned. We applied for and received grant funding, including possible interconnection for Woodhill Green. The Board has been working on the plan that was reviewed during our Workshop. (ARPA, grants and status update);

(ii) Mid-Point Park Sewer. This old sewer plant also needs to be decommissioned. Last year we received grant funding to begin the engineering study.

(iii) Village Water Interconnect. Last

week we closed on the \$1million NY State Grant funding for this intermunicipal project with the Village of Wappingers Falls. The grant covers 40% of the construction costs and the Village and Town each cover 30%

• **Parks and Park Facilities:** We will focus on projects further to improve our various parks and recreation facilities, including:

(i) Robinson Ballfields and Rockingham Park. Particular focus will be on repair to several facilities; competition of Challenger complex renovations; cleanup of the Rockingham pond; ongoing maintenance, etc.

(ii) Spookhill Phase II. By early spring 2022, Phase I will be finished. The Board discussed Phase II which we hope to commence in the Summer, 2022.

(iii) Martz Field. Various repairs and improvements were discussed.

(iv) Indian Village Playground. The addition of playground equipment was discussed.

• **Carnwath Farms:** Last year, Dutchess County awarded \$200,000 in grant funding for our new Recreation/Senior Center to be located on the 1st Floor of the Reese Cultural Center (in which the Sports Museum of Dutchess County is located). We are completing the engineering analysis for this project which we discussed during the Workshop.

All of these projects are designed to improve and enhance the quality of services to our community and especially the quality of life for our residents. During our Workshop we discussed not only specific projects for 2022 but long range planning as well. Additional projects will be discussed during a

second Workshop during early Spring 2022.

I welcome input from the community and we also welcome volunteers to

assist us with further planning and implementation.

# New mobile command post proposal sent to County Legislature for approval

To ensure Dutchess County continues to effectively and efficiently respond to emergency events, County Executive Marc Molinaro has forwarded a resolution to the County Legislature for the purchase of three vehicles critical the Department of Emergency Response's (DER) mission of preparing and responding to emergencies in the community, including a new state-of-the-art Mobile Communication Command Post vehicle.

Molinaro said, "Dutchess County remains committed to supporting the dedicated staff at our Department of Emergency Response, as well as Dutchess County's first responders, all of whom work daily to keep our residents as safe as possible. Investing in these vehicles allows the County to better respond to emergencies with a larger, fully outfitted command center; continue to provide valuable fire investigation services to local fire departments; and realize long-term cost savings, compared to costly leases. I thank the members of the Legislature for their shared pledge to keep Dutchess County and its residents safe, and I look forward to legislators' consideration and approval of this important investment."

The new Mobile Communication Command Post will be a 45-foot vehicle

equipped with state-of-the-art apparatuses to more effectively serve the community and will replace the current, 30-foot-long command post vehicle that has been deployed throughout the County for large-scale community events, including large events such as marathons, mass distribution of COVID-19 test kits and numerous local Community Day events, in addition to countless emergencies throughout its 17 years of service. The Mobile Communication Command Post serves as a shared resource for all emergency services in Dutchess County, including local municipal officials, law enforcement and emergency responders. Any agency can request DER to operate the Command Post at an emergency scene or pre-planned event as a central hub for incident command. The equipment in the current vehicle, however, has become outdated and no longer sufficiently meets various communication needs, due to limited internet, radio and network capability. Additionally, the size of the current vehicle is very restrictive, creating inefficiency for incident leaders.

Featuring a bus chassis, the new Command Post will have double the amount of usable workspace of the current vehicle, with "slide outs" to increase

space as needed, allowing both command and communications teams to operate simultaneously. The vehicle will be equipped with IP based radio and computer equipment that is easy to replace as technology changes. It will feature both satellite and advance bonded cellular networking and there will be connectivity to County and 9-1-1 computer networks allowing access to the 9-1-1 phone system and Computer Aided Dispatch (CAD) software. Local emergency service agencies will be able to connect to their technology and networks as well. The vehicle is being purchased through New York State bid for \$1.5 million, and is available for quick delivery from the manufacturer, despite recent supply chain issues.

DER will also purchase a new Fire Investigation Division (FID) vehicle, replacing its outmoded, 25-year-old predecessor. The FID assists local fire chiefs at the scene of

incidents to determine the cause and origin of fires or explosions. The members of the FID are highly trained volunteers who are on-call 24 hours a day and, in 2021, the team investigated 54 incidents. The new vehicle will house equipment and tools necessary for investigations and will feature a separate interview

room to assist investigation on-scene and will be purchased for \$500,000.

The vehicle purchases are part of the County's goal to have resources where they are needed. The County has also recently ordered a Mobile Community Health Clinic vehicle—which will be centered on serving outlying communities in northern and eastern Dutchess County, but available to every community. This mobile unit will expand the County's health services and allow recovery coaches to offer more residents full-service physical and behavioral wellness services, including infectious disease services and testing; immunizations, such as COVID-19 vaccinations; and intake screenings, referrals and links to community partners. This customized vehicle has an extended delivery timeline due to ongoing supply chain issues.

The \$2.1 million emergency response vehicles purchase will be funded through an appropriation from the County's General Fund balance. The Dutchess County Legislature's Public Safety Committee reviewed the resolution its Legislative Committee meeting on Thursday, Feb 10 and the full Legislature was to vote on the purchase approval at its Board meeting on Monday, Feb. 14.

## Marist lowers COVID-19 alert level on campus

In a sign we might be inching back toward some sense of normalcy, Marist College announced last week it is lowering its COVID-19 campus alert level from orange to yellow.

The change took effect on February 10.

The Town of Poughkeepsie college had been operating on something similar to a traffic light system – red being the worst, followed by orange, yellow and finally green meaning all things are normal.

"This improvement is a direct result of our work together: students, faculty, and staff committing to our three pillars of public health: masking, vaccination including boosters, and symptomatic testing," Marist vice-presidents Geoff Brackett, Thom Wermuth and Deb DiCaprio wrote in an email to students and parents. "We are extremely grateful to each of you who have complied with the guidance and appreciate

your efforts."

The yellow means just what you think it does – slow down and proceed with caution. Wearing masks on campus and to classes is still in effect, but dropping the alert means events on campus can proceed again.

- External visitors are permitted in residence halls with a completed Marist Guest Attestation.

- Events Comprised of ONLY Marist Community Members has increased to 70 percent capacity.

- Food and drink may be served at events; however, masks must be worn when not actively eating or drinking.

- Events Comprised of external and Marist Community Members are also increased to 70 percent capacity.

"Our goal is to continue managing our public health to reduce COVID-19 risk and allow the dashboard to get to green," the VPs wrote.

## Sheriff's Office investigates fatal crash in Union Vale

The Dutchess County Sheriff's Office reports the investigation into a one-car fatal crash which occurred on Verbank Club Rd in the Town of Union Vale at approximately 6:30 pm on Feb 12.

Deputies responded to Verbank Club Road near North Clove Rd in the Town of Union Vale for a report of a serious crash. Preliminary investigation has shown that a 2021 Audi Q5 operated by Avinash Harrindranauth, age 28 of Union Vale, was traveling south on Verbank Club Road when the operator failed to negotiate a hillcrest and slight curve in the roadway, after which the vehicle exited the roadway and struck a tree.

Harrindranauth, who was the sole occupant, was transported to Mid-Hudson Regional Hospital with life-threatening injuries and was later pronounced dead at the hospital.

The cause(s) of the crash is still under investigation by the Sheriff's Office Detective Bureau and Crash Investigation Unit, however at this time unsafe speed is thought to be a primary factor.

The Sheriff's Office was assisted at the scene by the New York State Police, Union Vale Fire Department, LaGrange Fire Department, and EMStar and more information may be released as it becomes available.

WHEREAS, it is hereby determined to be in the public interest of the Town to refund all or a portion of the said outstanding Refunded Bonds by the issuance of the refunding bonds authorized by the refunding bond resolution summarized herein pursuant to Section 90.10 of the Local Finance Law; and

WHEREAS, such refunding will only be undertaken if it results in present value savings in debt service as required by Section 90.10 of the Local Finance Law; NOW THEREFORE, THE TOWN BOARD OF THE TOWN OF FISHKILL, COUNTY OF FISHKILL, STATE OF NEW YORK, HEREBY RESOLVES (by the favorable vote of two-thirds of all the members of said Town Board), AS FOLLOWS:

Section 1. For the purpose of refunding the outstanding principal balance of the Refunded Bonds as more fully set forth in the Refunding Financial Plan (hereinafter defined), including providing moneys which, together with the interest earned from the investment of certain of the proceeds of the refunding bonds authorized by the refunding bond resolution summarized herein shall be sufficient to pay: (i) the principal amount of the Refunded Bonds; (ii) the aggregate amount of the unmatured interest payable on the Refunded Bonds to and including the date on which any of the Refunded Bonds which are callable are to be redeemed prior to their respective maturities in accordance with the Refunding Financial Plan (as hereinafter defined) and attached to the refunding bond resolution summarized herein as Exhibit B and made a part thereof; (iii) the costs and expenses incidental to the issuance of the refunding bonds hereinafter authorized, including without limitation, the development of the Refunding Financial Plan, costs and expenses of executing and performing the terms and conditions of the Escrow Contract (as hereinafter defined), and any securities supply contract, the premium with respect to any bond insurance policy or policies acquired with respect to the Refunding Bonds (as defined below), discount or compensation of underwriters, fees of bond counsel and financial advisors, rating agency fees, printing and serv-

ice agency fees and expenses, and fees and charges of the Escrow Holder (as hereafter described); and (iv) the redemption premium, if any, to be paid on any of the Refunded Bonds which are to be called prior to their respective maturities; there are hereby authorized to be issued in one or more series not exceeding \$2,400,000 aggregate principal amount of refunding serial bonds of the Town pursuant to the provisions of Section 90.10 of the Local Finance Law (the "Refunding Bonds"), it being anticipated that the amount of Refunding Bonds actually to be issued will be approximately \$1,910,000 as provided in Section 3 hereof. The Refunding Bonds shall be dated such as shall hereafter be determined by the Town Supervisor pursuant to Section 3 hereof, shall be of the denomination of \$5,000 or any integral multiples thereof (except for any odd denominations, if necessary) not exceeding the principal amount of each respective maturity and shall mature annually and shall bear interest semi-annually thereafter on such dates as shall be determined by the Town Supervisor pursuant to Section 3 hereof, at the rate or rates of interest per annum as may be necessary to sell the same, all as shall be determined by the Town Supervisor. The proposed principal amounts and dates of maturity of such Refunding Bonds are set forth in the Refunding Financial Plan attached to the refunding bond resolution summarized herein as Exhibit B.

Section 2. It is hereby determined that pursuant to Section 90.10:

(a) the maximum amount of the Refunding Bonds authorized to be issued pursuant to the refunding bond resolution summarized herein does not exceed the limitation imposed by subdivision 1 of paragraph (b) of Section 90.10 of the Local Finance Law with respect to the Refunded Bonds;

(b) the maximum period of probable usefulness permitted by law at the time of the issuance of the Refunded Bonds for the objects or purposes for which the Refunded Bonds were issued is as shown in Exhibit A attached hereto;

(c) the last installment of the Refunding Bonds will mature not later than expiration of the maximum period of probable usefulness of the objects or purposes for which the Refunded Bonds were issued, or in the alternative, the weighted average remaining period of probable usefulness of the objects or purposes (or classes of objects or purposes) financed with the Refunded Bonds, in accordance with the provisions of Section 90.10(c)(1) of the Local Finance Law;

(d) the estimated present value of the total debt service savings anticipated as a result of the issuance of the Refunding Bonds, computed in accordance with subparagraph (a) of subdivision 2 of paragraph b of Section 90.10 of the Local Finance Law, is as shown in the Refunding Financial Plan described in Section 3 hereof and attached to the refunding bond resolution summarized herein as Exhibit B, subject to changes in market interest rates;

Section 3. The financial plan for the refunding authorized by the refunding bond resolution summarized herein (the "Refunding Financial Plan"), showing the sources and amounts of all moneys required to accomplish such refunding, the estimated present value of the total debt service savings and the basis for the computation of the aforesaid estimated present value of total debt service savings, are set forth in Exhibit B attached hereto and made a part hereof. The Refunding Financial Plan has been prepared based upon the assumption that the Refunding Bonds will be issued in the aggregate principal amount of \$1,910,000 and will mature, be of such terms, and bear such interest as set forth in the Refunding Financial Plan. The Town Board of the Town recognizes that the principal amount of the Refunding Bonds, the series, maturities, terms, interest rate or rates borne by the Refunding Bonds, the provisions for redemption thereof prior to maturity and whether or not all of the Refunding Bonds will be insured, and the resulting present value savings are likely to vary from such assumptions and that the Refunding Financial Plan will likely vary from that attached to the refunding bond resolution summarized herein as Exhibit B. The Town Supervisor is hereby authorized and directed to determine the principal amount of the Refunding Bonds to be issued, the series and designation or designations thereof, the time or times of the sale

thereof, the maturities and terms thereof, the provisions relating to the redemption of the Refunding Bonds prior to maturity, if any, including the date and the amount of such redemption or redemptions, whether or not the Refunding Bonds will be insured in whole or in part or uninsured, the amount of the annual installments of the Refunding Bonds to be paid pursuant to the Local Finance Law, whether the Refunding Bonds shall be sold at a discount in the matter authorized by Section 57.00 of the Local Finance Law, and the rate or rates of interest to be borne thereby, and to prepare, or cause to be provided, a final Refunding Financial Plan, all in accordance herewith, and all powers in connection therewith may be exercised by the Town Supervisor; provided, that the terms of the Refunding Bonds to be issued, including the rate or rates of interest borne thereby, shall comply with the requirements of Section 90.10 of the Local Finance Law. The Town Supervisor shall file a copy of a certificate determining the details of the Refunding Bonds and the final Refunding Financial Plan with the Town Clerk within ten (10) days after the delivery of the Refunding Bonds, as herein provided.

Section 4. The faith and credit of the Town are hereby irrevocably pledged to the payment of the principal of and interest on the Refunding Bonds as the same respectively become due and payable. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on the Refunding Bonds becoming due and payable in such year. To the extent that the same are not paid from other sources, there shall be annually levied on all the taxable real property in the Town a tax sufficient to pay the principal of and interest on the Refunding Bonds as the same become due and payable, subject to applicable statutory limitations imposed by Chapter 97 of the New York Laws of 2011 of the State.

Section 5. Each of the Refunding Bonds authorized by the refunding bond resolution summarized herein shall contain the recital of validity prescribed by Section 52.00 of the Local Finance Law and the Refunding Bonds shall be general obligations of the Town, payable as to both principal and interest by a general tax upon all the taxable real property within the Town, subject to applicable statutory limitations imposed by Chapter 97 of the New York Laws of 2011 of the State.

Section 6. A complete copy of the refunding bond resolution summarized herein is available for public inspection during regular business hours at the Office of the Town Clerk, 807 Route 53, Fishkill, New York 12524 and on the Town's website <https://www.fishkill-ny.gov/> for a period of twenty days from the date of this publication.

## Deadline to upgrade to Enhanced STAR exemption March 1

The New York State Department of Taxation and Finance reminded seniors that, for most localities, the deadline to apply for greater property tax savings through the Enhanced STAR property tax exemption is March 1.

To be eligible for the 2022 Enhanced STAR property tax exemption, seniors must:

- currently receive the Basic STAR property tax exemption;
- have one owner of the property who will be at least 65 years of age by December 31; and
- have had 2020 income equal to or below \$92,000.

"We want every eligible senior to receive the increased property tax benefit," said Acting Commissioner Amanda Hiller. "To help ensure that seniors don't miss out on this valuable benefit, we recently sent letters to 27,000 seniors who may be eligible for additional savings."

Eligible seniors should apply to their assessor's office by the application due date, which is March 1 in most towns and some cities, but there are exceptions. Seniors should verify their exact due date

with their local assessor.

To apply, seniors must provide the following to the assessor:

- Form RP-425-E, Application for Enhanced STAR Exemption
- Form RP-425-IVP, Supplement to Form RP-425-E
- Proof of income: 2020 New York State or federal income tax forms. (If the senior wasn't required to file an income tax return, the assessor can guide them on how to provide proof of income.)

In 2021, 577,000 seniors received a total of more than \$800 million in savings from the Enhanced STAR property tax exemption.

Seniors who receive the STAR credit instead of the STAR exemption don't need to apply or take any other action. The Tax Department will automatically upgrade them to Enhanced STAR if they qualify.

## Fuel spill update

During Sunday morning, Feb. 6, a fuel tanker truck filled the underground tanks at the Gulf station on the northeast corner of Old Hopewell and Route 9. During the end of the process, approximately 50-75 gallons of fuel oil leaked out of one in-ground tank when a safety sensor alarm failed to operate properly, allowing some gasoline to overflow the in-ground tank.

The Hughsonville Fire Department responded immediately according to proper protocol observed by the Gulf station to contain the spilled gasoline to the Gulf station lot: the Fire Department put down booms and speedy dry to contain the spill. The gas pumps were shut down for cleaning.

United Pump & Tank installed a replacement overfill cap in the tank and

as well as an electrical overfill shut off switch on the exterior of the building. Older stations such as this Gulf station do not have these safety mechanisms, while new stations are required to have these and many other safety features to ensure that such spills do not occur.

DT Consulting Services Inc. provided on-site consultation services while employees properly cleaned up the site.

Haz-Mat visited the site and confirmed that all cleanup and remedial actions were properly executed.

The DEC has an open spill number that is not yet listed on their website. We have not yet received anything stating the DEC that has cleared the site.

Under the instruction of Supervisor Thurston, Town of Wappinger Code Enforcement Officer, Susan Dao, was on site making sure that proper procedures and disposal were followed.

## Lawrence T. 'Lonnie' Wilkins

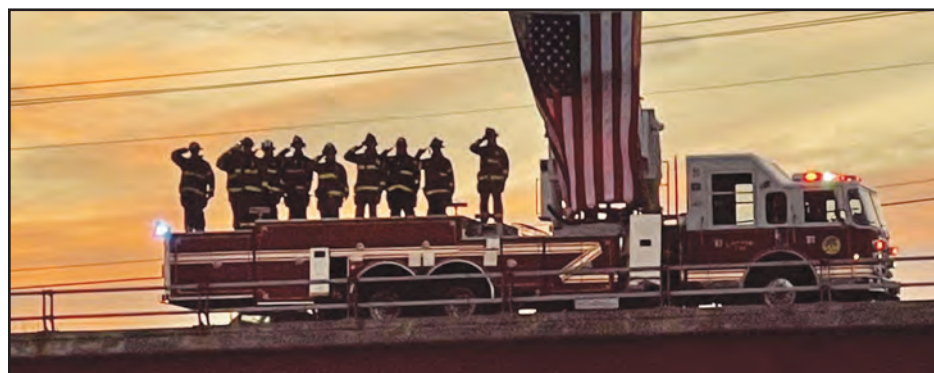

## Longobardi's celebrates 40 years of bringing Italian dishes to local area Restaurateur plans to retire

This year marks the 40th anniversary of Longobardi's Restaurant Pizza & Catering in Wappingers Falls.

Longobardi is the village where Claudio Giliberti, owner of Longobardi's, lived in Italy. He moved to the United States in 1970. He was 16 years old.

Claudio said he enjoys "that I'm able to provide the people with the food they like and make a living."

Claudio and his wife, Joanne Giliberti, moved to Wappingers Falls from Yonkers, Westchester County in 1980. At that time Claudio and his business partner, who was his brother-in-law, Arturo Nigrelli, (who still works and assists at the restaurant), began Longobardi, which has existed in a few different locations before its current one at 1574 South Road (Route 9).

"In 40 years, you meet so many people. You become friends with them. You meet all different people," Claudio remarked.

Claudio is now looking to sell the business. He is going to retire, he said.

Asked what some of the most popular dishes on the menu are, Claudio responded the chicken parmigiana, Nona pasta. There is also the Chicken Longobardi, which is artichoke heart, sun-dried tomatoes and hot peppers or one could choose the Shrimp Longobardi over pasta. Still cannot decide? There is the mushroom and pepperoni pizza or choose one of the other toppings. There are a variety of desserts, coffee and drinks available as well.

What would he order off the menu? "I would order lasagna with meat sauce if I was here as a customer," responded Claudio. Or he added, a dish that was made with veal.

"When you realize it's 40 years, half of my employees weren't even probably born yet," Claudio remarked.

The past two years, and during other economic uncertainties, have not made it always an easy thing to run a restaurant.

When the pandemic first hit, Claudio

said they offered take-out. While they were open for business, they "donated a lot of food," to such places as a local hospital and a Poughkeepsie church.

"There were a lot of people who could not cook - not that they could not afford it (the food)," remembered Claudio, who said that made him realize how many people depend on restaurants.

For four decades Longobardi's has supported the community, one way has been with sponsoring a girls softball team, said Claudio.

"For any small business, to reach 40 years is quite impressive, especially in the restaurant industry. But thanks to my friend Claudio Giliberti and his staff, his restaurant has become a landmark for fine Italian cuisine, meeting friends and family, and making memories that will last a lifetime. Congratulations on four decades," said Dutchess County Legislator Joseph Cavaccini.

Asked about the feedback he receives from the guests at the restaurants, he said, "Once in a while, you get a Friday or Saturday, and the place is full. That means people want to come in. It's a sign people want to come and are happy. Ninety-eight percent of the time you get 'Oh my God, everything was good,' you get that kind of response."

On the restaurant's website, www.longobardisrestaurant.com, Claudio and Joanne's adult children wrote: "We want to congratulate our father, but also thank him. The example that Claudio has set for us as a dad, as a businessman, and as a person has made the two of us who we are today. Neither of us will succeed him, but we think it's safe to say that when he's ready to hang up the apron and stop screaming "Menus!," no one would be able to fill those shoes anyway. Additionally, we want to thank Arturo Nigrelli, who partnered with Claudio for so many years and worked just as hard to provide that example for his own family in making the name Longobardi's syn-

## love to cook

## This takes the (cup)cake

Sweeten the winter days with these luscious treats

What a wild ride this winter has been so far! Certainly not the snowiest on record, but with temperatures dipping way below freezing and then in the upper 40s the next day, sleet, ice storms and just enough of the cold white stuff to mess up the occasional morning commute, it hasn't been without its challenges. At least where I live. Still, I can't say I've found it all unpleasant. Curling up and cozy on the couch with my dog and a warm blanket to watch a movie on a cold day does tend to make one grateful. And days like these are just made for baking: the smell of something in the oven just before it's done, the dusting of cocoa powder on the cheeks, the spoon to lick, that first bite you reward yourself with – that makes for a good day in my book!

Now before you think I've lost my mind – I've haven't. Quite – I do know that you will be reading this sometime after February 14, even as I'm writing this before Valentine's Day. Why is that important? Because the recipe I'm about to share is one I came up with for Cupid's favorite holiday. Sure, I could just as easily have left that part out or saved all this for a more timely article, but then I thought about it and decided I needed to share it now because, well, love. Who says you can't just surprise those you love with a little something, just because? I don't need no stinking holiday to tell me when it's the right time to show affection! So here we are, about to extend the love!

Before we get to the recipe, though, a

few more thoughts. One of the challenges of baking this time of year is the whole "room temperature" thing. My kitchen is none too toasty in winter, it being an old house with a high ceiling and drafty windows. So leaving something out of the fridge to warm up doesn't happen so much. When it comes to things like butter, which needs to be of a certain softness to whip into spreadable smoothness, there are ways to soften it up without overdoing it as you (and by 'you' I mean 'I') might in the microwave. It's important to get it to the right temperature: too cold and it won't aerate (which is what recipe directions call creaming) and will give you dense cake or clumpy frosting; too warm and the air bubbles collapse and will again be dense or just collapse the end result.

And just what is considered room temperature? Most agree about 60 degrees, but you don't need a thermometer to test it. Just poke your butter. If it leaves an indent without completely losing its shape, consider it ready. So, if your house is typically as chilly as mine, or if you didn't have time to naturally bring your butter to room temp, pour some boiling water into a heatproof bowl, let sit for 15 seconds or so, empty and place it upside down over your butter for several minutes. I check it after 5 and flip it over. If it still isn't soft enough, try cutting it into pieces first. Trust me, it's important! I was too pressed for time when I last made this recipe and my too-cold butter gave me lumpy unattractive frosting. (insert

frowny face) Now back to the love...

#### CUPID'S CHOCOLATE CHERRY CUPCAKES

Oh, I'm sorry: Did I fail to mention these rich, delicious babies are gluten free?! Never mind that now – you really can't tell. Besides, this way EVERYONE gets some love! And, yes, you can make these gluten-ful if you prefer. Heck, you can even use boxed cake mix. I won't judge. It's really more about the combination of flavors and the presentation. You can also play with different fillings. I think I might try cream cheese whipped cream next time or even whipped marshmallow!

Also worth noting is that I use really good Maraschino cherries; that is natural ones, not the freakishly neon pink variety. My brand of choice is Bada Bing and I can't recommend them enough! You're likely to find them near ice cream or cocktail fixin's in stores. I use them a lot and with good reason. They look and taste like cherries. Go figure!

#### Gluten-Free CHOCOLATE CUPCAKES

##### INGREDIENTS:

6 tablespoons butter, cut into pieces  
1/2 cup Dutch-processed unsweetened cocoa powder  
1/3 cup strong brewed coffee  
1 cup sugar  
1 cup all-purpose gluten-free flour (Bob's Red Mill 1-to-1 is a good one) OR 3/4 cup rice flour and 1/4 cup tapioca flour  
1/2 teaspoon baking powder  
1/2 teaspoon salt  
1/4 teaspoon baking soda  
1/3 cup sour cream  
2 eggs  
1 teaspoon vanilla  
6 maraschino cherries, patted dry, stems removed, cut in half  
12 whole maraschino cherries, patted dry (optional)

##### CUPCAKES METHOD:

Preheat oven to 350 degrees. Place cupcake liners in a standard 12-cup muffin tin.

Melt butter over a double boiler. Sift in cocoa powder, then stir in coffee until smooth and well combined.

In a large bowl whisk together sugar, flour(s), baking powder, salt and baking soda. Mix in sour cream, eggs and vanilla, just to combine. Stir in chocolate mixture.

Divide evenly among prepared muffin tin cups, filling each about 3/4 full. You may have enough to make a few more – lucky you!

Bake about 25 minutes until a toothpick inserted in center comes out clean. Set on a rack to cool. You can do up to this step a day ahead.

Cut a small cone in the top of each cupcake and cut the cone so just the top remains (you get to eat the other part!). You'll be putting your filling in the hole and replacing the top before topping with ganache.

#### CHOCOLATE GANACHE

You can make this while the cupcakes bake so it has time to chill. Better yet, make it a few hours ahead so it really sets up.

##### INGREDIENTS

1 cup heavy cream  
8oz bittersweet chocolate, finely chopped

##### METHOD:

Heat cream in a small saucepan until hot and steamy – DO NOT boil or the chocolate may separate and your ganache won't be smooth.

Place chocolate in a heatproof bowl and pour the hot cream over top, give a stir and let sit 10 minutes to melt the chocolate. Mix until glossy and smooth. Chill until it sets up enough to spread, about 1 hour.

#### CHERRY FROSTING/FILLING

##### INGREDIENTS:

6 tablespoons butter, softened  
2 cups confectioner's sugar  
1/2 teaspoon vanilla  
4 tablespoons Maraschino cherry juice

##### METHOD:

Combine butter, 1 cup of the sugar and the vanilla. Beat well until smooth and creamy. Add remaining cup of sugar and cherry juice and blend until very smooth. It should be a beautiful shade of dark pink.

Chill to set a little. Place a small zip-top bag into a glass and fold it over the sides to hold it open. Spoon filling into the bag, zip it up and cut a small triangle off one tip of the bag. Squeeze some filling into each cupcake hole, top with half a cherry, replace the cupcake cap and press slightly to make it level with the top.

Spread ganache on top of each cupcake and top with a whole cherry. Makes 12.

With weeks of chilly weather yet to come, why not bake up some love? It's worth celebrating so much more than once a year, after all! Enjoy!

## James Brown, Gardener

### Tours at Mesier Homestead set in honor of Presidents Day



Mount Gulian's head gardener left a diary filled with interesting historical tidbits and snippets of everyday life in the 19th century.

James Francis Brown was born into slavery in 1793, but escaped from a Maryland plantation at age 25. Making his way to New York City, Brown found employment as a coachman for the Verplanck family at their Wall Street townhouse. The Verplancks owned an estate on the Hudson River just north of the present-day city of Beacon (then known as Fishkill Landing), which they called Mount Gulian, after the family patriarch, Gulian Verplanck.

James Brown transferred to Mount Gulian in 1829 to become head gardener. He was intensely interested in politics, religion, temperance and, above all, gardening. The 4,000 page diary he kept is a treasure trove of anecdotes and observations about everyday life in Dutchess County 180 years ago.

• May 3, 1829 (first entry) – "Took a walk in the woods this day and found a very pretty bunch of water flowers; brought them home and gave them a place in the flower garden among the wild plants in the collection."

• May 28, 1829 – "Today the weather has been quite pleasant although the morning was cloudy, early in the morning. The carpenters began the fence round the new garden."

• March 5, 1810 – "Early this morning the weather was clear and afterwards it clouded over very like rain. Sloop passed down the river today but was stopped by the ice. The seeds in the hot beds well up. Mrs. DeWindt dined with Mrs. Verplanck."

• May 14, 1838 – "One part of this day has been cloudy and then it has been very warm. This day sowed tomatoes (in hot beds), cauliflower, broccoli and early york cabbage. Trimmed bean poles and stakes for raspberries and shot a wild cat. The ice on the river

is breaking up very fast. The ferry boat Enterprise came cross the river for the first time this season but there has been no steam boat up from New York."

• August 16, 1942 – "Earthed up the celery the 3rd time."

• September 16, 1842 – "Preparing for the State Fair."

• September 18, 1842 – "We went to the state fair in Poughkeepsie and returned in the afternoon."

• February 3, 1845 – "Very cold. Thermometer 1 above zero. Finished filling ice house and in the night it began to snow and continued until morning. Mr. Adriance lost a horse through the ice in the River between the Long Dock and Low Point on the flats."

• July 4 1845 – "Worked all day in the garden. The weather cool and pleasant. In the evening went to see the fireworks at Newburgh."

• August 19, 1845 – "No rain yet. Ripe muskmelons for the first time this season. The weather is very dry. But yet we have a good supply of vegetables. There is at the time exhibiting in Orange County a mammoth skeleton of great size. First discovered and taken from a mine pit six miles west of the village of Newburgh, it is certainly a great ancient curiosity. It is visited by a great many people."

• July 28, 1851 – "The Steamer Henry Clay burned and many lives were lost among them was Mrs. J.P. DwWindt, A.J. Downing, Mrs. Wadsworth. Planted peas and beans for a late crop."

• March 4, 1853 – "President Pierce was this day inaugurated into office as President of the United States of America. Planted early peas. The weather warm and clear until

evening, it clouded over and began to snow."

• March 1866 (last entry) – "The lowest tide that has been for years in the Hudson River...Persons could walk right down to git eels and fish with the hand."

Mount Gulian Historic Site will be open for tours this spring. On the website, click on "virtual tours" to see a video about James Brown, which explores his professional relationship with Mary Anna Verplanck, who designed the original garden in the English Formal style. As a free person of color, and as a free-spirited woman, James and Mary Ann were both way ahead of their time.

Tours will be open for the 1741 Mesier Homestead in Wappingers Falls on Sunday, Feb. 20. In honor of Presidents Day, tours on this day will include tidbits about connections to the village, town and hamlets have to past Presidents. Guided tours of the Homestead are led by volunteers from the Wappingers Historical Society. Tours will begin at 1 p.m. Last tour is at 3:30 p.m.

Visitors will learn about the early history of the Mesier Homestead, beginning in 1741 when the Brower family settled here, built the first stone house in the village and developed mills along the Wappingers Creek. Discover the story of Peter Mesier, a Tory loyalist, his store and the Wappingers Tea Party of 1777. Explore the Victorian Era-styled rooms of the Homestead and their displays of local antiquities, and see a portion of our collection of Native American artifacts.

The Homestead is located at 2 Spring Street Wappingers Falls. Tickets for tours are \$10 for adults, \$7 for seniors, \$5 for youth aged 7-18. WHS members and children under the age of 7 are free. For more information, please call 845-632-1281.

Meals are taken in a dining area with breakfast and lunch as self-service and menus with cloth and traditional dinner settings for dinner. You are free to seat with whomever you choose, a great opportunity to make new friends.

You're up early in the morning, as that is when the animals are roaming. Your afternoon is free until you go out on the second drive of the day. This is when the nocturnal animals start to roam and you get to watch them move as the sky turns from orange to red and fades to purple dusk.

**Australian interests**

I have been to New Zealand, a part of Oceania, but my first choice of places to

visit was Australia. I'm very glad that I visited New Zealand, and highly recommend it, however, as an animal lover, I really wanted to see kangaroos in their natural habitat and that place is in Australia.

For others whose interests include natural landscapes, likely the most interesting and natural place to visit would be Uluru. Formerly known as Ayers Rock, was named so by Ernest Giles a European explorer who discovered the massive rock in 1872. Mr. Giles named the rock Sir Henry Ayers in honor of the South Australian Premier. However, according to many sources of information, Uluru is the traditional and cultural land of the Pitjantjatjara and Yankunytjatjara people (also collectively known as the Anangu people).

According to the Australian website, within the Uluru area, many carvings and paintings created by these people can still be found, and a number of special sites of sacred significance to these indigenous people — which are, appropriately, closed to the public — are also located in this area.

**Asia beckons**

I have been to Asia twice, visiting Hong Kong and Korea, but have long wished for a trip to Cambodia. My main interest in Cambodia is to visit Angkor Wat, a UNESCO World Heritage Site, and a Buddhist temple complex. It was built in the 12th century by Khmer architects working with sandstone and manual labor.

Located in Siem Reap Cambodia, Wat translates to both monastery or temple. The construction and ornate designs of the buildings both fascinate me as does the age of the structures. While many other buildings were constructed during that

unique period, Angkor Wat continues to fascinate me.

about the area. Yet, it is still the place I hope to visit first after it is safe to again travel. Arizona is the place where my mother and my second father live. As many times as I've visited there before, I still wish to visit again.

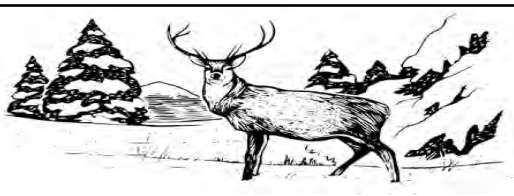
