HV Ukrainian community watches, prays as war explodes

The Ukrainian American Community in the Hudson Valley is watching events unfold in Ukraine with horror and individuals are working to provide support to the victims. The community has come together like never before, sharing information about events, about family members, and about ways to help.

The situation is frightening - and galvanizing the community. Many are trying to understand how it could have been

allowed to happen.

Ukraine has a long history and its people have a national identity that stretches through the Kieven Rus back to the Ninth Century. The Ukrainians have been fighting for or protecting their independence from Russia for centuries.

Father Ivan Kaszczak, the pastor of the St. John the Baptist Ukrainian Catholic Church in Hunter and also of Holy Trinity Ukrainian Catholic Church in Kerhonkson, is busy looking after his flock and looking to communicate with their families, whether they be in Ukraine

or already refugees somewhere else.

"People are worried about family and friends back there," he says. "One of my friends was working in Kyiv, but has managed to get to Hungary with his wife and two kids.

"We, here, are ready to sponsor refugees to come to USA when that can happen. Right now, though, most of the wives don't want to leave their husbands,

who are staying and fighting. We will be ready when the time comes."

"This whole thing is surreal," Father Kaszczak says. "Putin has said that he is doing this to protect the Russian speakers." in Eastern Ukraine. Yet, his troops are destroying Kharkiv, one of the largest Russian speaking cities in the world. (Kharkiv is third behind Moscow and St. Petersburg -2017 census data). If they are 'our brothers,' why are they killing us?"

Father Kaszczak continues, noting that "Putin talks of 'de-nazification.' I only know of two countries in the world where both the president and the prime minister were Jewish. One is Israel and the other, up until recently, is Ukraine. This truly is surreal.'

Orest Temnysky, first generation Ukrainian American and a trustee of the St. John the Baptist Ukrainian Catholic Church in Hunter, has been active in helping to coordinate aid and has been in close touch with family still in Western Ukraine. Most are elderly relations.

"They worry about the shelling," he says. "My aunt is in her 80s and lives on the 14th floor of her building. She doesn't think she can get down to shelter in the basement in time.
"If it comes," she says, "I'll just be

closer to God here.'

Local legend Brian Giorgis to retire from coaching next year

It's funny now to think about, but the most successful girls and women's basketball coach that Dutchess County has ever known had his doubts.

At least twice, in fact.

In 1987, Brian Giorgis led the Our Lady of Lourdes High School girls team to the New York State Public High School Athletic Association tournament for the third time. He lost in his previous two trips, but the Warriors won the state title this time.

A relieved Giorgis was asked after the game how he felt and said, "I was feeling like Bud Grant, like I was never going to win this thing," he said of the Minnesota Vikings football coach, who reached the Super Bowl four times without winning.

After winning nine state high school titles, Giorgis was courted by Marist College, just a few miles up the road from Lourdes in the town of Poughkeepsie, to become its new coach. Yet he still had his doubts and, in fact, he went to the Lourdes administration and said, "If this doesn't work out, can I come back?"

There was no going back. Giorgis continued his success at the collegiate level and, last week, decided that next year, the 2022-23 season, will be his last on a basketball

sideline as he has decided to retire. He will be replaced by his former player and longtime assistant coach, Erin Doughty.

"It's been an incredible ride, but it's time," Giorgis said. "As sad as I am to see the light at the end of the tunnel, I am extremely excited for the future of Marist women's basketball. Marist could not have made a better choice than Coach Erin Doughty to continue the legacy of Marist women's basketball. She brings the enthusiasm, knowledge, and spirit of what the program has been about for the last 20 years, and I am confident that Erin can bring the program to even greater heights. I thank Tim Murray, Deb DiCaprio, Dennis Murray, and Kevin Weinman for one of the most incredible journeys that a coach could ever have, and I thank them for having the vision to see that Coach Doughty can take the program even further.'

Giorgis is currently in his 20th season as head coach of the Red Foxes. He has the best track record of championship success of any coach in the 40-year history of Metro Atlantic Athletic Conference women's basketball. Giorgis led the Red Foxes to their first MAAC championship in 2004, won nine straight conference crowns from 2006 through 2014, and



Local residents: War in Ukraine is replica of past

For Esther Kando Odescalchi, this has an all-too-familiar – and sad, and frightening, and frustrating - feeling.

When Russia's invasion of Ukraine went from rumor to reality on February 24, Odescalchi was flooded with the searing memories from her childhood when, as a teenager, she and her family escaped from Hungary in 1956 after the former Soviet Union invaded the country to quell a rebellion.

"What's happening in Ukraine right now is the exact replica of what happened in Hungary," said Odescalchi, a Pleasant Valley resident for nearly 50 years now. Like other area residents with ties to Ukraine, she is keeping a keen eye on the current developments.

"In 1956 we had enough of the Iron Curtain," she said of Communist rule. "The revolution was winning, but the west, just like now, was doing nothing. I remember as a young person, the Russian tanks coming in and bombarding my city and crushing the Revolution.'

Most of her memories are sad and poignant.

Most of them.

"I remember when the Russian tanks were coming into Budapest and we were just outside of the city," she recalled with a laugh. "One of the soldiers asked me and a bunch of children which way it was

to Budapest. We all pointed and told them it was the opposite direction of the way they were going and they turned around and actually headed away from Budapest! Even the smallest children did something

to defend their country."

Odescalchi is, quite literally, standing with her Ukrainian friends, helping to organize donations to help the people affected by the war. There's a kinship there – Ukraine actually used to be a part of Hungary more than a century ago and Hungary was the first country in the world to recognize Ukraine's sovereignty when it declared independence in 1991.

"I am proud," she says, "that Hungary is welcoming so many refugees from Ukraine right now."

Much as Austria welcomed Odescalchi and her family in 1956. Not long only after a harrowing escape from Hungary, she wrote a book called "My Escape – Memoirs of a Hungarian Teenage Freedom Fighter."

Odescalchi chronicled the escape, including getting lost in a swamp and being unsure if her family was traveling toward Austria or back into the arms of Soviet soldiers. But they made it to the border nation and, in 1957, she came United States a refugee.

She completed her education in the United States, earning a MS in library science and a Ph.D. in communications from Columbia University. After a career as a librarian, she met her husband – who was employed by IBM in Poughkeepsie - and she too joined IBM and worked in executive communications. She lectures and conducts workshops at colleges, universities, national and international organizations in the United States and abroad.

When Russia came to Hungary, they kicked my father out of his job, they made us move from our house to a one-room place. The pipes were always frozen. We went hungry," she said. "To this day, I still appreciate that my heat turns on when I get cold, that I can take a hot shower, and that I don't want for food. The United States is still the greatest country in the world, even at this exact moment, and anybody who thinks otherwise can go to hell.

Ulana Salewycz

For Ulana Salewycz, her memories are similar.

Salewycz is a Poughkeepsie resident whose parents left Ukraine as refugees after World War II, escaping the murderous regime of Soviet Chairman Josef Stalin.

"This is not the first time this has happened in our history," Salewycz said. "In fact, it's probably the fourth or fifth time. But before (the 1986 nuclear reactor

accident in) Chernobyl hit, most people didn't know that much about Ukraine. Now people know."

After her family settled in America, Salewycz was born and raised in a heavily Ukrainian area in Passaic, New Jersey. She and her siblings learned Ukrainian and lived in a three-level home with her grandparents on the top floor, her own family in the middle and her sister and her family on the bottom floor.

Ukrainians are like mushrooms. You meet one and you see there are a lot of us in different parts," she joked.

Salewycz is active in the Hudson Valley's biggest Ukrainian community in Kerhonkson in Ulster County, including the Ukrainian Women's League of America and the Ukrainian Holy Trinity Church. She still has cousins currently living in Ukraine, and her aunt gives the family updates as often as possible. So far, one in Lviv and one in Kyiv, are safe.

She said the current invasion does not surprise her.

The Orange Revolution has been going on for eight years," she said. "Putin wants the old Soviet Union back. He's going to keep going. (Former Russian president Mikael) Gorbachev was friendly to the Ukrainians, but most of the Russian leaders are not to be trusted."

He says his family isn't leaving yet. "The line at the border is so very long and they are in their 80s. They can't sit in a car

for three days waiting. They're stuck."
"There's got to be more that can be done," remarks Temnycky. "We are watching in slow motion the murder of thousands of people. I don't see how he (Putin) is going to stop."

Luba Fedun, a Ukrainian American, laments, "I've been to Ukraine so many times since the break up of the Soviet Union and at last count, I had 176 relatives still there. I've been in touch with an elderly aunt. Her father was killed by the Nazis just before she was born, and when the Soviets returned after driving out the Nazis, they exiled her mother. My aunt was only three months old, so her mother handed her to her own sister to look after her as she couldn't survive the exile with a tiny baby.

The aunt lives in the Kherson Oblast (district) in southern Ukraine. Kherson was the first major city to fall to the Russians recently. "I was in touch with her until the Russians came," Fedun said, "And now there is no more communication with anyone there. She's elderly and we're all worried."

The area community, represented by the Mountain Top Interfaith Community, hosted an interfaith prayer service at the Ukrainian church in Hunter on this past Sunday afternoon. The better part of 200 people packed the facility. Father Kaszczak led the service with help from the interfaith council. The whole community joined in praying for peace and for the safety of the Ukrainians but also for the Russian soldiers.

"We wish no one any harm," Kaszczak reminded everyone. "We simply pray that the Russian soldiers will find it in their hearts to stop the fighting."

While donations for humanitarian aid to Ukraine were being accepted at the church on Sunday, Father Kaszczak announced that, on a larger scale, humanitarian aid donations are being coordinated through the Church by the Ukrainian Catholic Church's Metropolitan in

Philadelphia.

"They, like Catholic Relief Services, (CRS) have very little overhead and most of the donations will go directly to those in Ukraine or refugees, who have gotten out," he said.

Dismayed at another gasoline spill in Wappinger

To the Editor:

I was dismayed recently to learn of yet another gasoline spill in the Town of Wappinger, but at least as disturbing is the lack of public notification of the incident. With the prospect of yet another gasoline station being built in a residential area (Rte. 9D in Hughsonville), this potential for a serious health emergency is particularly frightening. The DEC website lists three local gas spills in the last five months: one in September 2021, one in December 2021, and now this most recent spill in February.

Recently I contacted Mr. Thurston, copying other members of the Town Board. I was pleased to receive an immediate response from Mr. Thurston. He referred to the "small spill" as having been successfully cleaned up. His response to my concern about not being notified was that he had spoken to the press. As far as I know, both of these answers are correct. However, what he did not say is that the "small" spill of 75 gallons (as reported on the DEC website, which also states "Date Spill Closed: Not Closed") would be substantial should it occur in or near someone's backyard, as could happen in a residential area. He never addressed my concern that there had been no verbiage on the Town website to let residents know that the spill had occurred. I also asked him why a mass phone notification of residents was not done but did not receive an answer. Perhaps the Town does not have that capability?

Now we are facing the possibility of yet another gas station in a potentially dangerous location. For some reason that I cannot fathom, our Town Board decided to rescind its restriction on building gasoline stations in residential areas. Despite public opposition to the Hughsonville plans, the Town has yet to recognize the dangers that this proposal presents. As I write this, multiple outlets are reporting the destruction or damage to buildings in Rockville Center, NY, resulting from a 9200 gallon gasoline spill; Hughsonville is slated to house 24,000 gallons of gasoline. Even if there were roadway improvements designed to relieve the bottleneck that normal traffic in Hughsonville already experiences on a regular basis, the opportunity for disaster is ripe. Try to imagine evacuating this residential population, especially during the impending arrival or departure of a train, in a safe and efficient manner as emergency vehicles are attempting to access the area.

Upon receipt of Mr. Thurston's email, I thanked him for his promptness and then asked him to address these concerns. When I did not hear from him, I gave him the courtesy of a second opportunity to respond but have yet to hear from him or any members of the Town Board. Accidents do occur for which there can be no blame or recrimination, but in situations as potentially deadly as this our elected officials have been charged with the responsibility of doing everything within their power to protect the citizens whom they serve. The 2019 building code that prohibits placing gasoline stations in residential areas must be reinstituted.

Huber, Niznik and Lauricella were sent questions regarding the upcoming election. Huber and Niznik did not respond by deadline.

Lauricella stated, "I am registered No Party. I'm not getting bogged down with political ideologies that have no place in small government on this level. I'd like to avoid the toxic rhetoric we see on the national stage. I don't think it's helpful. That being said I'm grateful to have received both the Republican and Democratic nomination. It speaks to my ability to stay the course and work toward resolution. I'm not pushing one parties agenda. I'm pushing the people's agenda. I'll continue to work for all residence regardless of political affiliation and this vote of confidence shows that.

Lauricella said, "I've been focused on several really important issues. Many are not totally resolved, so I will stay vigilant throughout my term as a trustee. First, Fiscal

responsibility. We're in serious fiscal distress. We have to weed out those people and firms who see the Village as an easy mark, a cash cow who is willing to endlessly spend. It's been going on in the Village for years and it can't happen any longer. I'm working to identify the trouble areas, the big-ticket invoices and subpar work and to replace them with people in line with needs and goals of the Village. We've been working to stop the bleeding. However, I strongly believe we also need to spend when necessary. We can't hold back financial support from our departments. We have an obligation to equip them with the tools they need and we must compensate our people. We need to set people up for success. In this job climate, it's the only real way to attract new talent and more importantly, retain the hardworking people we already have. So, it's a tightrope. We'll be walking it for many years to get out of this mess. I think with time we can become financially healthy again."

Lauricella noted, "I'm working with all

departments within the Village to make it a better place. We need to improve the visual landscape of this village to give our current residence and business owners a sense of pride. This will also attract new neighbors, positive people who will become the fabric of our community in the future. The days of allowing absentee landlords and lazy property owners to degrade our buildings to the point of blight are over. It can't happen any longer. We deserve better. This will also lend to an increase in property values. And for most of middle-class America, their home is the largest part of their nest egg, wouldn't it be nice if Village property values were on trend with the rest of the county? I think so. So many people have lived here for decades, generations even...they should be seeing a return on their investment. It should be a real

factor in their net worth."

Lauricella remarked, "I also want to let people know, the Village of Wappingers is open for business. We want to welcome new small business owners in and give them an avenue to establish and grow responsibly without unnecessary pushback. We should have laws and regulations that allow people to live their dream, to create jobs and earn Sales tax in a way that doesn't discourage them, burn them out or bankrupt them. Let's work with developers and show them a path to development. Responsible developers with a proven track record are key to any neighborhood revitalization. They put a lot on the line to develop. Blood, sweat, tears and a lot of capital. It's a risk, and we should appreciate that they're taking such a risk in our little Village. Still, we have to let them know, it needs to be done responsibly. In needs to be done right. In America, we want people to develop and make money...but not at the expense of the Village and its people."
"I would just like to say I really appreci-

ate those people who have confidence in me. I work hard to serve my community and will continue to do so. I think this role I'm playing is an important one. I would also like to thank my wife and kids for supporting me in this. It demands a lot of my time and they have been really cool about it. I think the Village is at a critical time and if we play our cards right we can make great things happen," said Lauricella.



The transfer of incarcerated individuals to other facilities began shortly after the closure announcement and gradually decreased the facility's population. Incarcerated individuals were transferred to other facilities based on their security

classification, as well as medical and mental health needs.'

Under internal pressure from its own student body, Vassar College has replaced its original commencement speaker for its May 22 graduation.

Out is Jeh Johnson, the Roy C. Ketcham High School graduate.

In is noted actor John Leguizamo.

Johnson was Vassar's original choice for the school's 158th commencement and seemed like a great local choice. Not only did he graduate from RCK in 1975, but his father was a professor at Vassar who designed a building on campus now known as the Jeh Vincent Johnson ALANA Cultural Center.

The younger Johnson rose to become the U.S. Secretary of the Department of Homeland Security under the Obama Administration. But his rigid stance on strong border control and immigration reform did not exactly endear himself to a segment of the Vassar student body in this time of woke culture.

In announcing he would withdraw his name from consideration two weeks go, Johnson said in a statement that "I believe commencements should be joyous, tension-free events for graduates and their families. In my public life, I managed many difficult and contentious issues. In my private, life I do not seek to be the object of controversy or speak at a commencement where students will object to me. I continue to be grateful for all Vassar is doing to honor my late father's legacy as a lecturer there for 37 years.'

Leguizamo also has strong - and familial - ties to Vassar. His son is currently a junior at the school and his wife graduated from Vassar 32 years ago.

The actor has had notable turns in movie roles in "Carlito's Way" and "Summer of Sam," as well as serving as the voice of Sid the sloth in the popular animated "Ice Age" series. But he was also on campus just two years ago filming the television miniseries "The Green Veil."







Martial Arts school serves community with blood drive, Polar Plunge





He kissed me on the cheek and slapped my other cheek. He turned away from me and went into the walk-in cooler to get his ingredients for dinner. At that moment I thought my head was about to explode. I could almost hear Frank Sinatra singing "The Impossible Dream." I wasn't sure,

but I think he paid me a compliment.

Tira Mi Su **Ingredients**

6 egg yolks

3/4 cup white sugar

1 1/2 cup milk

1 1/4 cups heavy cream

1/2 teaspoon vanilla extract

1 pound mascarpone cheese

1 cup strong brewed coffee, room temperature

4 tablespoons brandy

4 tablespoons Kahlua

4 (3 ounce) packages ladyfinger cookies 1 tablespoon unsweetened cocoa powder

Method

In a medium saucepan, whisk together

egg yolks and 1 cup of sugar until well blended. Whisk in milk and cook over medium heat, stirring constantly, until mixture boils. Boil gently for 1 minute, remove from heat and allow to cool slightly. Cover tightly and chill in refrigerator 1 hour.

In a medium bowl, beat cream with vanilla until stiff peaks form. Whisk mascarpone into yolk mixture until smooth. Add chilled custard and gently whisk until blended.

In a small bowl, combine coffee, 1/2 cup sugar, brandy and Kahlua. Dip lady fingers into the coffee mixture.

Arrange half of soaked ladyfingers in bottom of a 7x11 inch dish. Spread half of mascarpone mixture over ladyfingers. Sprinkle with cocoa. Repeat layers and again sprinkle with cocoa. Cover and refrigerate 4 to 6 hours, until set.

To serve, cut into a 3-inch squares and garnish with whipped cream.

Luigi Coppola is one of five brothers born to Francesca and Antonio Coppola. The Coppola family came to America from Naples, Italy in 1954. Antonio and his brothers opened their first restaurant in Poughkeepsie in 1961. Luigi and his brothers Nick, John, Antonio and Vincent have carried on the family tradition in the way their parents taught them, using classic recipes taught to them at their apron strings. Are you ready to travel?

Make your plans now to get ahead of the rush

Are palm trees and tropical breezes calling your name? Are you contemplating taking the kiddos to the magical parks of Florida?

If so, you might be ready to travel. Even if you're not yet ready to travel, it's time to start planning. The travel industry has seen a wild uptick in travel requests. 

Discovering Ann Blake: The challenges of recovering women's voices from the past

For historians, genealogists, and other researchers, the challenges of recovering stories from the past on anyone other than elite men are well known. The further back one goes in time, the more those remnants of other voices are filtered through the perspectives of those elite men, sometimes to the point where the original tone and words are lost. That is, in part, why we have the discipline of history, with specific methods for addressing bias in the historical record, and themed months, to encourage people to think more widely.

It seems fairly obvious and easy to accept that the experiences, attitudes, and ideas of women living in the seventeenth, eighteenth, and even the first half of the nineteenth century would be difficult to recover. We must not lose site of the fact, however, that this obscurity of women's voices extends into our modern era of living memory. Readers born since the 1980s, and particularly those whose lives began in the twenty-first century may find this idea difficult to imagine, but women's individual identities were hidden behind the mantles of their husbands well into the 20th century.

Back in 2013, when I was conducting the research for the Dutchess County Government exhibit that still hangs on the 6th floor of the Dutchess County Office

Building at 22 Market Street, I thought I knew all about the difficulties of seeing through the haze of old customs to access the details of women's lives.

Pride cometh before a fall, as the old expression goes, and I was in for a wake-up call. In reviewing the press coverage from the Poughkeepsie Journal archives and sifting through the layers of government reports, I repeatedly encountered one woman (the only woman) on the Charter Commission

The writers of these sources always referred to her as Mrs. Edwin T. Blake. For those readers of a more recent vintage, this custom of referring to married women by their husband's name carries back well before the foundation of Dutchess County in 1683. Usually, there are ways to work around that issue, but not in this case. Try as I might, I could not locate a single written source recording this individual's given first name.

An accident of fate that you can experience for yourself today offered the solution to this puzzle. Following in the footsteps of many historians, and perhaps drawing from a few too many detective novels, I returned to the scene of the event, in this case the Dutchess County Legislative Chambers. During the debates of 1965-1967, this room belonged to the Dutchess County Board of


Supervisors. A small bronze plaque located to the right of the entrance to the chambers commemorates the "vision, wisdom, perseverance and continued untiring effort" of the Charter Committee of the Dutchess County Board of Supervisors and the Dutchess County Charter Commission. Located below this inspiring proclamation, dated April 17, 1967, are the names of the members of the committee and the commission. Tucked between W. Carlton Bernard and Joseph MacAvery is Ann Blake. Finally, an answer to a months-old question.

Additional research quickly revealed that Ann Blake, the mysterious Mrs. Edwin T. Blake, was a key member and one-time president of the League of Women Voters of Greater Poughkeepsie. A Native of Litchfield, Connecticut, she earned her BA from Smith College and MA from Vassar College, and chaired the League's County Charter and Reapportionment Committee before joining the County Charter Commission in 1966.

She served in many other civic capacities, including the Model City Advisory Council during the years of peak Urban Renewal in Poughkeepsie and the building committee for the LaGrange Town Hall. Unfortunately, additional details on her life and experience remain elusive, offering yet another reminder of how challenging research can be. Attendees will hear tales ranging from Elisabeth Hitchcock's lawsuit against Robert Howe for failing to marry her to

Elizabeth Ryhert's unfortunate and violent encounter with the Reverend Johann Christofells Hartwick in Rhinebeck. We will discover how court records can be wonderful for preserving moments and experiences that would otherwise be lost to time, while also being a source of extraordinary frustration due to the absence of "the rest of the story," as Paul Harvey put it. Thursday's program is free and accessible via the world wide web: visit dchsny.org/march10 to sign up.

In the meantime, I advise readers to think carefully about their experiences and those of their friends, family, and loved ones can be recorded for posterity. The 1960s were an especially vital time for Dutchess County, a decade that seems a lot closer than it actually is to 2022. When going through old photographs or speaking to folks with memories of that era, give some thought to preserving those stories for future generations.

'We will be boiling our collected sap on a homemade evaporator that we built two years ago, and over an open fire. We will be offering tastes of our own syrup as well as some local products, sap straight for the tree, and a few goodies made with maple syrup," said Richard "Rick" Soedler, with the East Fishkill Historical Society (E.F.H.S.) and Site Director of the Brinckerhoff House Historic Site, about what attendees can expect at the annual event. The E.F.H.S. is hosting the event. In 2021, the society held tree in-person

events and a school field trip.

'[T]hey all went very well. So, this won't be new to us, just less restrictions as mandates have been lifted," stated Soedler.

There will be a 20-minute video presentation in the one-room schoolhouse, The video shows the maple operation of Dr. Julian Strauss, who owns and lives on a farm in Amenia that he grew up on, explained Soedler.

"Not many people extract using buckets anymore. It's a very time-consuming process, with a 40 to 1 ratio. It takes 40 gallons of sap to make one gallon of syrup. This is one of the reasons it is so expensive to buy," noted Soedler.
