Consideration is the exchange of benefits and detriments by the parties to an agreement.

- Benefits are something that a party was not entitled to receive.
- A **detriment** is any loss suffered.
- May include **forbearance**, not doing something you have the legal right to do.

Agreements Without Consideration – the following are UNENFORCEABLE

Mr Wehmann says, "On July 1st, I promise to pay each of you \$25 if you do not do any drugs, or drink alcohol for the rest of the school year."



Promise to Obey the Law

- Everyone is obligated to obey the law.
- I promise to give you \$100 if you do not drink alcohol this weekend.

- 1. A tenant in an apartment pays the \$900 in rent for November. The water stops working in the apartment. The landlord says, "if you pay me another \$100 extra, I will turn on the water." Does the tenant have to pay the \$100 extra?
- 2. You pay the pizzeria \$2 for a slice of cheese pizza. When receiving the slice you say "can you just throw some pepperoni on there for me"? Will you have to pay more for it?

Preexisting Duty

 If you are already under a legal duty to do something, a promise to do that <u>same thing</u> does not mean you get any more consideration.



Frazier - Agreement with God - 3

• If you are to receive something for a certain price, you do not get something more for the same money.

contractor performs work on a home for \$10,000, then refuses to finish the job unless the homeowner agrees to pay another \$2,000

Do I have to pay you?


Past Consideration

• Giving or exchanging benefits and detriments must take place when the contract is made.



Illusory Promise

- Both parties must be under obligation to do something.
- Some contracts are **illusory** (have a false appearance)
- "I will give you ten dollars when I feel like it"



How many triangles are present in the image below?

Promise to Make a Gift

- Judge Judy Mom-Daughter Loan or Gift? 10min
- A **gift** is something given freely, for no consideration.
- If someone later refuses to make the gift, there is no breach of contract.

Adequacy of Consideration

- Courts usually don't judge whether the consideration was fair to both parties.
- The courts may find the contract **unconscionable**, so one-sided that is unfairly one party and unreasonably favors the other party.

Is this Unconscionable?

The Sanchezs alleged that they were pressured when Caitlin, then 12, took the job to voice Dora back in 2007 by Nickelodeon and the teen's agent, Jason Bercy, into signing a 14-page contract after being given only 22 minutes to review the mountain of documents and were not permitted to see an entertainment attorney to go over the deal.



Apparently Caitlin gets only \$5,115 per episode and \$40 a day when she has to travel and promote the highly successful series which rakes in billions.

Special Applications of Consideration

Each promise made as consideration for another promise must create a new obligation.

Settlement of Disputed Claims

- If an amount is really in dispute; cashing a check that states "Payment in Full" is treated as the acceptance of the smaller amount... and the balance cannot be recovered.
- If the amount is <u>not</u> in dispute (price is clearly stated and agreed upon); then cashing a check that states "Payment in Full" would <u>not</u> pay off the debt.

Partial Payment of a Debt



Do we have to accept your late payment?


- on time payments qualify as consideration and the debt must be reduced.
- if your payment is late, no additional consideration was given and the debt doesn't need to be reduced.

Extension of Time for Payment

• If a loan agency/person offers to extend the time allowed to pay, they are not bound by the promise because the debtor offered nothing new.

Pledges and Subscriptions

• Usually involve charitable projects and are in the public interest so the courts will try to find a way to enforce them.



Promissory Estoppel

- Under **promissory estoppel** a promise may be enforceable without consideration.
- Promissory means promise
- \bullet Estoppel restraint on a person preventing him/her from contradicting a previous act .
- Needs three conditions, an example....
 - 1. Promise must be made to do/not do something.
 - 2. The second party must have relied upon the promise and made a change.
 - 3. Enforcing the promise is the only way to avoid an injustice to the second party.
